

**Information Brochure for Beekeeper Garments
According to PPE Regulation (EU)2016/425 (Personal Protective Equipment)**

The PPE protects against bee stings by preventing bees from entering. The width of the clothing offers additional protection.

The garment fulfills the basic requirements of PPE regulation (EU)2016/425.

Prototype testing was done by TÜV Rheinland LGA Products GmbH, Tillystraße 2, D-90431 Nürnberg, identification no. 0197.

Selection of the most appropriate garment must be based on a risk analysis. The garment has to be tried on to determine the required size and to ensure a proper fit. Since the width of the clothing offers additional protection, it should not be too small or too tight. To ensure safety, please make sure that the garments are always completely closed, maybe with the appropriate combined articles. Cotton webbings and elastic bands have to be closed and fitted, in order to avoid the invasion of bees.

Before put on, the garment has to be checked for damages.

We recommend having necessary repairs carried out by suitable and competent companies. In order not to impair the function of the clothing, we advise against carrying out the repair yourself.

While not in use, the garment has to be stored properly, i. H. in dry, vermin-free rooms. Improper storage can cause damage to the product, which may compromise protection. Since this is a natural product, it may suffer from humidity and temperature fluctuations during storage and natural material changes may be observed over time. For these reasons, it is not possible to specify a date of expiry. Furthermore, the expiry time varies depending upon the degree of wear and tear and the field of application.

When stored in a cool, suitable place and protect from UV radiation, it will be best before:

The disposal can be done via household waste or used clothes bins.

If the garment is combined with a headgear with zipper, the headgear has to be removed before washing and is only washable by hand.

The garment (without headgear) is washable up to 60 ° C.

By washing, due to the natural material, a contraction between 5 – 10 % may be possible.

After washing both parts (model specific) has to be fitted together again and prior to re-use, the garment has to be checked for damages and replaced, if necessary.
