

**Information Brochure for Beekeeper Headgear
According to PPE Regulation (EU)2016/425 (Personal Protective Equipment)**

The PPE protects against bee stings by preventing bees from entering.

The headgear fulfills the basic requirements of PPE regulation (EU)2016/425.

Prototype testing was done by TÜV Rheinland LGA Products GmbH, Tillystraße 2, D-90431 Nürnberg, identification no. 0197.

The choice of headgear must be made according to a risk analysis and, depending on the model, combined with the appropriate article. It has to be tried on to determine the required size and to ensure a proper fit. In order to avoid the invasion of bees and to ensure safety, please make sure, that the headgear is always completely closed, maybe with the appropriate combined articles. It has to be built a closed unity. Elastic bands have to be closed and fitted.

Before put on, the headgear has to be checked for damages.

We recommend having necessary repairs carried out by suitable and competent companies. In order not to impair the function of the headgear, we advise against carrying out the repair yourself.

While not in use, the headgear has to be stored properly, i. H. in dry, vermin-free rooms. Improper storage can cause damage to the product, which may compromise protection. Since this is a natural product, it may suffer from humidity and temperature fluctuations during storage and natural material changes may be observed over time. For these reasons, it is difficult to specify a date of expiry. Furthermore, the expiry time varies depending upon the degree of wear and tear and the field of application.

When stored in a cool, suitable place and protect from UV radiation, it will be best before:

The disposal can be done via household waste or used clothes bins.

This item is suitable for hand-wash only.

Prior to re-use, the headgear has to be checked for damages and replaced, if necessary.
